(e.g., who seeks/is referred to treatment and why; efficacy and effectiveness) • What do we know about cannabis? (e.g., pharmacodynamics/pharmacokinetics of different strains, cultivation, preparation and consumption methods) • How do policy and legal frameworks impact on the people who use cannabis? • What is the future for cannabis research? (e.g., potential avenues for future research; aspects needing more attention; innovative approaches; political/funding issues affecting cannabis research)

Research for Educational Change Jun 16 2021 Research for Educational Change presents ways in which educational research can fulfil its commitments to educational practice. Focussing its discussion within the context of mathematics education, it argues that while research-generated insights can have beneficial effects on learning and teaching, the question of how these effects are to be generated and sustained is far from evident. The question of how to turn research into educational improvement is discussed here in the context of learning and teaching hindered by poverty and social injustice. In the first part of the book, four teams of researchers use different methodologies while analysing the same corpus of data, collected in a South African mathematics classroom.
